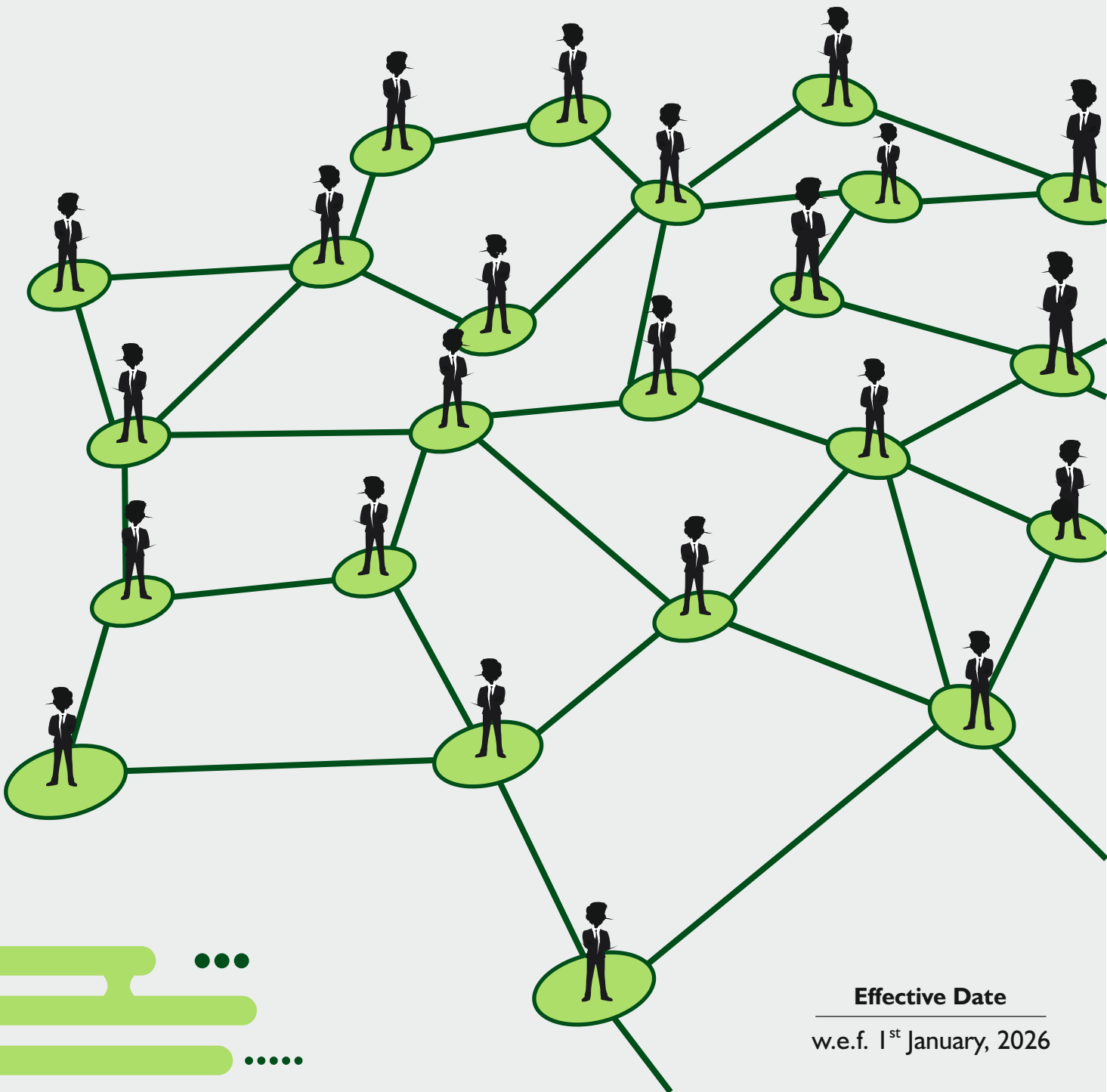

## 1) Retail Profit - Upto 25%

Computation :

MRP - Distributor Price = Retail Profit

Example :

Root Health 250 gm.

₹ 1,350 - ₹ 1,010 = ₹ 340

## 2) Customer Referral Bonus - 25%

Qualification :

The Distributor ID should be Pro Retailer or above with completed KYC.

Computation :

Suppose a product's MRP is ₹ 1,000 and the Distributor Price (DP) is ₹ 750, generating 450 BV. When an Independent Distributor's customer purchases this product, the Independent Distributor receives 450 BV as Self Purchase BV and earns 25% of 450 BV = ₹ 112.5 as Customer Referral Bonus

Note :

- This income is computed on business cycle basis.
- 4 business cycle every month: 1st to 7th, 8th to 14th, 15th to 21st & 22nd to month end.
- Actual business is calculated, after deducting return products business volume.
- All pay-outs are generated & paid post return window period is complete.

## 3) Direct Referral Bonus - 5%

Qualification :

The Distributor ID should be Pro Retailer or above with completed KYC.

Computation :

An Independent Distributor "U" has sponsored 3 Independent Distributor under his / her network: "A", "B" & "C".

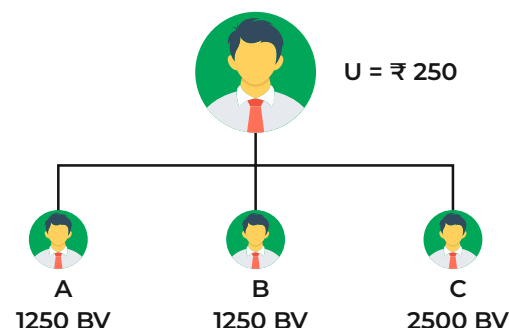
3 sponsored Independent Distributors purchased products of 1250 BV, 1250 BV & 2500 BV respectively. Then, Direct Referral Bonus for U will be calculated as:

A (1250 BV) = 1250 BV x 5% = ₹ 62.5

B (1250 BV) = 1250 BV x 5% = ₹ 62.5

C (2500 BV) = 2500 BV x 5% = ₹ 125

Total Direct Referral Bonus = ₹ 250



Note :

- This income is computed on business cycle basis.
- 4 business cycle every month: 1st to 7th, 8th to 14th, 15th to 21st & 22nd to month end.
- Actual business is calculated, after deducting return products business volume.
- All pay-outs are generated & paid post return window period is complete.

## 4) Sales Matching Bonus - 15%

### Qualification :

The Distributor ID should be Star Rank or above with completed KYC.

### Computation :

Distributors are remunerated on the matched BV between the Power Team and the Weaker Team. When both teams generate equal business volume, that portion qualifies for payout as the Sales Matching Bonus.

Independent Distributors earn 15% of the matched BV from the Weaker Team

### For Example:

An Independent Distributor generate sales of 1250 BV in Power team and sales of 1250 BV in Right Team, it makes him / her eligible to earn 15% of matching BV as Sales Matching Bonus.

- This income is computed on business cycle basis.
- 4 business cycle every month: 1st to 7th, 8th to 14th, 15th to 21st & 22nd to month end.
- Actual business is calculated, after deducting return products business volume.
- All pay-outs are generated & paid post return window period is complete.
- To earn sales matching bonus, Independent Distributors must have 2 personally enrolled teams.
- Matching BV beyond cap limit will be flushed-out from both the team. Unmatched BV will be carried forward to the next business cycle as per Leadership Rank wise carried forward limits defined by the company.

## 5) Performance Bonus - (5% of the Monthly BV Turnover)

### Qualification :

- Independent Distributor must achieve the Leadership Rank of Sr. Executive and above.
- Independent Distributor must have a minimum business matching of 25,000 BV every month.

### Computation :

$$\text{Performance Bonus} = \left( \frac{5\% \text{ of Company's monthly BV Turnover}}{\text{Sum of Matched BV of all Performance Bonus Qualifiers}} \right) \times \text{Your Matching BV}$$

### For Example:

Company business = 10,00,000 BV.

5% of BV Turnover = 50,000

Independent Distributor "A" has achieved the rank of Sr. Executive and has achieved a business matching of 30,000 BV in a month. Now he is eligible to earn Performance Bonus for the month.

Total matching business achieved by all the Performance Bonus achievers = 5,00,000 BV

$$\text{Formula} = \left( \frac{5\% \text{ of Company's monthly BV Turnover}}{\text{Sum of Matched BV of all Performance Bonus Qualifiers}} \right) \times \text{Your Matching BV}$$

$$\text{Performance Bonus for "A"} = \left( \frac{50,000 \text{ BV}}{5,00,000 \text{ BV}} \right) \times 30,000 \text{ BV} = ₹ 3,000$$

### Note :

- This income is computed on monthly basis.
- Actual business is calculated, after deducting return products business volume.
- All pay-outs are generated & paid post return window period is complete

## 6) Business Development Bonus - (3% of the Monthly BV Turnover)

### Qualification :

- Independent Distributor must achieve the Leadership Rank of Pearl and above.
- Independent Distributor must have a minimum business matching of 2,50,000 BV every month.

### Computation :

$$\text{Business Development Bonus} = \left( \frac{3\% \text{ of Company's monthly BV Turnover}}{\text{Sum of Matched BV of all Business Development Bonus Qualifiers}} \right) \times \text{Your Matching BV}$$

### For Example:

Company business = 1,00,00,000 BV.

3% of BV Turnover = 3,00,000

Independent Distributor "A" has achieved the rank of Pearl and has achieved a business matching of 4,00,000 BV in a month. Now he is eligible to earn Business Development Bonus for the month.

Total matching business achieved by all the Business Development Bonus achievers = 50,00,000 BV

$$\text{Formula} = \left( \frac{3\% \text{ of Company's monthly BV Turnover}}{\text{Sum of Matched BV of all Business Development Bonus Qualifiers}} \right) \times \text{Your Matching BV}$$

$$\text{Business Development Bonus for "A"} = \left( \frac{3,00,000 \text{ BV}}{50,00,000 \text{ BV}} \right) \times 4,00,000 \text{ BV} = ₹ 24,000$$

### Note :

- This income is computed on monthly basis.
- Actual business is calculated, after deducting return products business volume.
- All pay-outs are generated & paid post return window period is complete

## 7) Leadership Bonus - (2% of the Monthly BV Turnover)

### Qualification :

- Independent Distributor must achieve the Leadership Rank of Diamond.
- Independent Distributor must have a minimum business matching of 12,50,000 BV every month.

### Computation :

$$\text{Leadership Bonus} = \left( \frac{2\% \text{ of Company's monthly BV Turnover}}{\text{Sum of Matched BV of all Leadership Bonus Qualifiers}} \right) \times \text{Your Matching BV}$$

### For Example:

Company business = 10,00,00,000 BV.

2% of BV Turnover = 20,00,000

Independent Distributor "A" has achieved the rank of Diamond and has achieved a business matching of 30,00,000 BV in a month. Now he is eligible to earn Leadership Bonus for the month.

Total matching business achieved by all the Leadership Bonus achievers = 80,00,000 BV

$$\text{Formula} = \left( \frac{2\% \text{ of Company's monthly BV Turnover}}{\text{Sum of Matched BV of all Leadership Bonus Qualifiers}} \right) \times \text{Your Matching BV}$$

$$\text{Leadership Bonus for "A"} = \left( \frac{20,00,000 \text{ BV}}{80,00,000 \text{ BV}} \right) \times 30,00,000 \text{ BV} = ₹ 7,50,000$$

### Note :

- This income is computed on monthly basis.
- Actual business is calculated, after deducting return products business volume.
- All pay-outs are generated & paid post return window period is complete

## 8) Awards & Rewards

### Qualification :

The Distributor ID should be Star Rank or above with completed KYC.

### Monthly

### Computation :

Business Kit = Independent Distributor must match the sales of 40,000 BV in Power team and sales of 40,000 BV in Weaker Team in a month.

### Note :

- This award is Monthly.
- The Business Kit is available once per Independent Distributor.
- Training : Compulsory
